GENERAL CONDITIONS OF CONTRACT

Applicable Regulations

In signing this registration form, the exhibitor acknowledges that the Exhibitor Regulations are binding. MCH Swiss Exhibition (Basel) Ltd. reserves the right to issue and implement further orders and directives in individual cases. The provisions contained in the General Regulations and in the Stand Construction and Design Guidelines similarly apply.

Advance Payment (deposit)

An advance payment will be levied for the technical connections and other services (parking, telephone calls made, catalogue entry, etc.) together with the invoice for the stand rental (stand surface area up to 39 m² CHF 1,000.-; stand surface area 40 – 79 m² CHF 1,500.-; stand surface area 80 m² and more CHF 2,000.-; co-exhibitor CHF 500.-; system stand CHF 500.-). The advance payment will be offset against the effective costs incurred (final exhibition invoice).

Technical connections and services

All order forms may be found in our «m-manager» internet ordering service under www.m-manager.com as of April 2019. Please note that **partition walls will only be provided if ordered separately**. Once they have been allocated their stand position, exhibitors will be sent confirmation of their contract together with further information about m-manager. Technical connections and further services will only be provided if ordered on the special forms for these.

Data protection provisions

In signing the registration form, exhibitors agree to their personal and company data being processed by MCH Swiss Exhibition (Basel) Ltd. or a company commissioned by MCH, and to this data being passed on to a contractual partner of MCH Swiss Exhibition (Basel) Ltd. for purposes of providing services in conjunction with participation in the exhibition.
